

Delivering MTD compliance to Sybiz Vision users across the UK

You have likely been forwarded this information brochure by our mutual client to help share information about how Sybiz is preparing for Making Tax Digital for VAT.

Sybiz has been working with Her Majesty's Revenue & Customs to ensure our ERP solution, Sybiz Vision, continues to represent a robust VAT solution for our UK clients. We have managed similar legislative changes in Australia with a great amount of success and we are aiming for a similar outcome in the UK.

While there is little change expected operationally, Making Tax Digital may still have implications for the way you and your clients prepare VAT returns and maintain data integrity.

MTD for VAT enforces three key guidelines for VAT-registered businesses over the £85,000 threshold:

- Quarterly VAT returns must be reported digitally
- VAT transactions must be recorded and stored digitally
- VAT transaction data can only be transmitted or transformed by a 'digital link'

MTD at a glance

All VAT-registered businesses over the £85K threshold must be compliant

1 April 2019 is the start date, but your clients' first reporting period may differ

All VAT transactions must be recorded and stored digitally

Sybiz Vision will be ready to report before July 2019

These guidelines may change the way you interact with your client's data during and at the end of each reporting quarter, possibly requiring some more consultation with your client in preparing returns or more direct interaction with your client's ERP solution. In some cases, MTD might eliminate spreadsheets altogether.

While MTD for VAT will come into effect from 1 April 2019, it is important to understand when your clients' quarterly returns are due to know when they must be compliant. If your client typically reports for the April – June quarter, they will need to report their first digital VAT return no earlier than July 2019. If their reporting quarter does not begin in but is inclusive of April, the following quarter will be the first reported via MTD for VAT standards (e.g. if your reporting quarter is March – May, your first digital VAT report will cover the June-August quarter).

This will also determine when they must have digital links in place to ensure data continuity when passing between individuals and systems. The implementation of digital links is required 12 months after a business is due to report their first MTD for VAT-compliant return.

If you haven't already, now is the time to start consulting with clients about updating business processes for Making Tax Digital compliance.

Users across the globe have benefitted from a streamlined upgrade process to the new Sybiz Vision, allowing businesses to retain their historical data while gaining greater control over business processes and analysis.

Sybiz Vision Classic will be receiving a shortterm solution to facilitate VAT returns to HMRC. If using an older version your client may need to update before the release of our MTD for VAT-compliant capability.

Clients using Sybiz Vision Classic should plan to upgrade to the new Sybiz Vision by the end of 2020.
